**2. GENERAL TERMS AND CONDITIONS OF SERVICE**

By ordering on the website and its confirmation, an electronically concluded contract is established between FUTDEAL LLC. and the person using the service specified herein, according to the provisions of this General Terms and Conditions ("GTC").

The purpose of this GTC is to establish the regulations in connection with the subscriber relationship established between the parties, the use of the platform and the rights and obligations of the parties. By accepting this GTC, the subscriber accepts the participation and other conditions, rules imposed by FUTDEAL and considers such conditions and rules effective for them.

The day of concluding the contract is the day when FUTDEAL sends confirmation about the order of the subscriber to the subscriber.

During the term of their legal relationship with FUTDEAL, the customer is only entitled to the rights granted in the GTC concerning their activity. The Subscriber irrevocably waives their claims of financial nature not detailed in writing and not expressly granted in writing concerning their activity related to FUTDEAL.

FUTDEAL does not accept responsibility for any damages resulting from using the website and/or the information presented therein, and from the defective operation or inaccessibility of the website, including its different services, whether due to failure of internet connection and/or the fault of the internet service providers and/or the computers of FUTDEAL and/or the computer of the subscriber. Subscriber can exercise all their activities concerning FUTDEAL as a fully able person of age.

**3. GENERAL INTRODUCTION OF THE SERVICE**

FUTDEAL operates an online platform (gamer44) for connecting users to purchase and sale game keys, operated in a subscription system. Gamer44 is not a reseller digital store so it does not buy or sale digital products.

**4. TERMS AND CONDITIONS OF SUBSCRIPTION ON THE PART OF FUTDEAL AND OF THE SUBSCRIBER**

FUTDEAL offers 3 subscription options: Basic, Silver and Premium subscriptions.

The price for the Basic subscription is \$ 9.99, for which the subscriber receives selected basic and normal games as it's written on gamer44.com.

The price for the Silver subscription is \$ 32.97, for which the subscriber receives selected normal games as it's written on gamer44.com.

The price for the Premium subscription is \$ 84,3, for which the subscriber receives selected normal and premium games as it's written on gamer44.com.

We will gift you 3 games and 4 bonus spins during the 7 days free period, if you subscribe!

If any of the stated games are not available due to stock shortage, or the uploader sold us a wrong key, we will exchange it to another game with the same value.

FUTDEAL does not grant repurchase rights concerning subscriptions but grants 7 days free use for using the subscriptions so the subscriber can cancel the used service within 7 days. The subscriber can cancel their subscription any time before it expires, and the subscription is terminated when it expires. If the termination notice arrives on the monthly date of the subscription, the termination only becomes effective on the next subscription date. The same rule applies to the 7 days trial period specified in this section as well, adding that termination free of charge is possible until the end of the 7th day.

The subscriber is free to choose from the payment methods offered by FUTDEAL and can change payment method on the online interface during the term of the subscription. If the subscription cannot be renewed with the payment method selected by the subscriber on the day of renewing the subscription, then the subscription gets suspended and the subscriber is notified thereof.

Seller acknowledges that they should set the general terms and conditions of the sales made to the users.

Seller should solely comply to any applicable law (especially intellectual property rights, copyrights, personality rights) upon selling, Seller should not publish any false or misleading information concerning the product offered for sale, which may be detrimental to or may expose third party subscribers to any harm.

It is prohibited to seller to use the subscription for any illegal purposes or to violate domestic or international laws, including provisions relating to copyright, intellectual property rights and other property rights protection.

Seller should provide a proper description of the sale as: sales contract title, description, detailed activation method, returns, warranty, price, and photos. It may not include inappropriate content, content which infringes applicable laws or these GTC. The description should not contain any advertising content or promoting goods and services which are not offered on the portal. The description cannot infringe any rights of third parties (copyrights, intellectual property rights). Seller should withdraw any offer prior any unprocessed purchase.

FUTDEAL applies a commission for completed purchases on the portal. The commission paid by the seller is non-refundable. After the deduction of the commission,

**FUTDEAL pays out the purchase price to seller after 20**

**business days.** This term provides an opportunity to buyer to report any claims upon the respected purchase. In this

case the payment made by the subscriber for products or services purchased from the seller would have to be returned by the seller as a result of the subscriber complaint caused by faults of the products or services provided by the seller. Due to the commission being non-refundable, the seller is not entitled to claim any compensation from FUTDEAL may retain the sums of back commissions, contractual penalties and compensations costs which the seller shall cover.

Seller is solely responsible for playing any applicable tax liabilities in compliance with applicable laws. The Seller may sell pre-order products through the Gamer44 site. Pre-order products should be delivered to Gamer44 by the Seller on the day before release date.

Subscriber may buy pre-order product. Subscriber pays for pre-order products on the date of the order, but the product is sent to the subscriber on the date indicated on the platform. Subscriber acknowledges that the date of receiving of the pre-ordered product and/or the price may vary. In case of pre-ordered product revoking the price paid for the pre-ordered product is reimbursed by the selling subscriber.

Subscriber is eligible for purchasing security membership program which provides a guarantee to receive replacement product in case the purchased product was faulty or different from the description. If such a replacement cannot be granted the subscriber who bought the security membership shall receive a full refund for the said purchase. Subscriber is entitled to use the benefits of the security program only in the period when the respected security subscription is active. The security membership program does not transfer any responsibility of seller (see above).

FUTDEAL shall not in particular bear any responsibility against any third parties related in particular to nonperformance or improper performance by the seller of his agreement with the User (or other seller), or to any delict committed by the seller, any infringement by the seller of the law in force or related to any false information, assurances or statements submitted by the seller. ## **5. REGISTRATION**

In the course of the registration, the subscriber must provide a real e-mail address, name, address and password.

In the course of the registration, it is mandatory to provide the personal data required for providing the service and invoicing. The system does not accept registration without providing the mandatory data.

After registration, FUTDEAL sends confirmation to the subscriber electronically, to the e-mail address provided during registration about the successful registration of the subscriber.

After registration, the subscriber can log in by entering their e-mail address/login name and their chosen password.

By signing the registration, the subscriber at the same time authorizes FUTDEAL to process, store and use their personal data as intended.

FUTDEAL performs the processing of personal data provided in the course of registration according to the provisions of its effective Data Processing Regulation. The subscriber can modify their personal data provided in the course of registration. The subscriber is responsible if they do not modify changes in their data to be mandatorily provided accordingly, and as a result, the subscriber cannot use the service.

If the subscriber forgets their password, it is possible to request sending a new password from FUTDEAL to their e-mail address provided in the course of registration. The new password is good for logging in one time, then the subscriber can modify it to a password chosen by the subscriber after logging in.

## **6. DATA PROCESSING CONDITIONS**

FUTDEAL LLC. records and stores the accompanying data of the request and confirmation conducted on the online contract conclusion interface provided by FUTDEAL LLC and the content of the request filled in by the subscriber. The subscriber acknowledges that FUTDEAL LLC. is entitled to store and process the data provided by the subscriber and to forward such data to the persons contributing to the provision of the service. Additionally, the subscriber acknowledges that FUTDEAL LLC is only responsible for the security of data forwarded on the internet to the extent it concerns data stored in its own electronic system.

In the case of a natural person, the subscriber acknowledges that the data protection statement shall be accepted online.

## **7. AMENDMENTS OF THE GTC, TRADEMARK RIGHTS**

The amendment of the GTC shall be considered approved by the change being accepted by the subscriber after being notified. The customers and website visitors are not entitled to the unauthorized use of trademarks, product labels, illustrations, images, symbols used by FUTDEAL except if the person concerned gave their prior consent to this. In case of violating this obligation FUTDEAL is entitled to terminate this contractual legal relationship with immediate effect, besides enforcing other rightful claims. The subscriber gives their consent to FUTDEAL for sending offers with marketing purposes, advertisements personally, by telephone, SMS, online communication platforms or e-mail messages, to the extent required for the operation of the system. If the subscriber objects to this in writing, then FUTDEAL shall not be entitled to contact the customer with notices with such content in the future. The subscriber – considering the following – gives their consent to FUTDEAL for the assignment or other transfer of this agreement or its rights and obligations under it to a third-party enterprise already with this contract. In the case of contractual legal succession, FUTDEAL is obliged to publish this event on the FUTDEAL website within 30 days before the actual legal succession at the latest. If the subscriber notifies FUTDEAL in writing within 15 days from the publication of this legal succession that they do not intend to be in a contractual legal relationship with the legal successor, then the legal relationship between the parties is terminated on the day before the effective date of the legal succession and FUTDEAL cannot give the data of the subscriber to the legal successor.

This rule is not applicable to the general legal succession realized according to legal regulations /e.g. transformation, separation, spin-off, merger, etc./

## **8. INVALIDITY**

Should certain stipulations of the subscriber agreement and of this GTC (hereinafter: the agreement) be deemed invalid, this invalidity does not concern the entirety of the agreement. The provisions of the agreement not affected by the invalidity remain effective and enforceable, and instead of the provisions concerned an effective rule related to the legal relationship between the parties that is the closest possible to the invalid provision shall be applied, except if the parties would not have concluded the contract at all without the invalid provisions or the provisions deemed to be invalid.

## **9. APPLICABLE LAW, COURT JURISDICTION**

In matters not provided for in the subscriber agreement and in the GTC the laws according to the registered office of the company operating the FUTDEAL website shall be applicable to this legal relationship. The parties subject themselves to the jurisdiction of the court operating in the USA to decide any dispute arising from this contract or related to it, in connection with its breach, termination,

validity or interpretation. FUTDEAL LLC., as the central operator of www.FUTDEAL.com, and the websites under the subdomains, reserves the right to unilaterally amend this General Terms of Use. Registered members shall be notified in a short message on the website about potential amendments and conditions concerning products; the same applies to visitors of the site.

FUTDEAL acknowledges that the confidentiality obligation it undertook also extends to third parties it involves in the performance of the contract. FUTDEAL shall advise such persons about the confidentiality obligation specified in the

contract and about compliance with this obligation and shall certify such compliance to the subscriber at any time. The confidentiality obligation has no limitations as to time, if the legal regulations do not provide otherwise. The publication of any of the above data in order to perform any

obligation required by legal regulations by any party is an exception from the confidentiality.
